2. Standards for preparing Soft Drink Beverage

For soft drink beverages other than mineral water, frozen fruit juice drinks, and fruit juices used as raw materials.

(1) General standards

Apparatus and containers / packages used in manufacturing the beverage are washed in a suitable manner and shall be sterilized, expept those unused containers / packages which have been sterilized or manufactured by a method with sterilizing effect and handled with care so as not to be contaminated before use.

(2) Specific standards

The water used as the raw material must conform to Water Quality Standards or otherwise to the specifications ① or ②.
